The Contractor will not be liable to the Government in a breach of warranty action for consequential damages resulting from any defect or deficiencies in accepted items.

In the event that the terms of the contractor's standard commercial warranty/limitation of liability clause(s) place greater limits on the contractor's liability than do the terms contained in this clause, the terms of this warranty policy will govern the contract.

packing materials, all manuals, blank warranty cards, accessories and any other documentation included with the original shipment. Shipping charges on returned items are the customer's responsibility.

DOC Development will accept all responsibility for shipping charges (both ways) on exchanged defective items within 45 days of purchase. Please request a UPS return shipping label and one will be emailed to your account. For your protection, we strongly recommend you fully insure your return shipment in case of loss or damage. Please use a carrier that is able to provide you with proof of delivery.

Please refuse damaged merchandise from any carrier attempting delivery. If you accept the package, make sure it is noted on the carrier's delivery record.
